- The rates should remain valid for the period up to March 2024. The rates once accepted will not be changed under any circumstances. The violation of any of the conditions will entitle cancellation of the order.
- 2. Photocopy of Professional Tax return for the last financial year, PAN No., Current Trade license and must be submitted proof of at least two years of work experience in Govt. premises & educational institute along with the quotation.
- The tender inviting authority shall verify the abovementioned documents (In original) which are mandatory for the
  participation before issuance of the work order.
- Payment of bills on its production will be made after successful supply and complete installation of the items stipulated time
- 5. The tender bid will be out rightly rejected if it comes to the notice of the tender inviting authority during scrutiny that the credential or any other paper of a tenderer is fabricated etc.
- 6. The undersigned reserves the right of accepting or cancelling the tender without assigning any reason.
